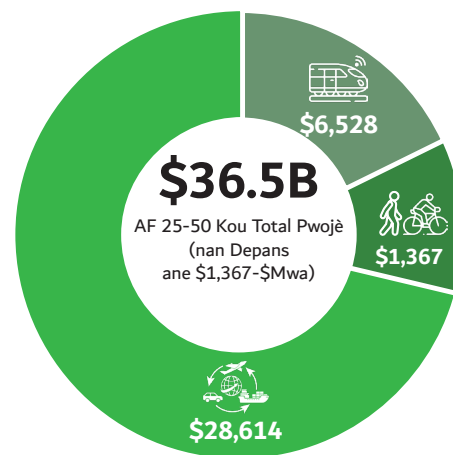
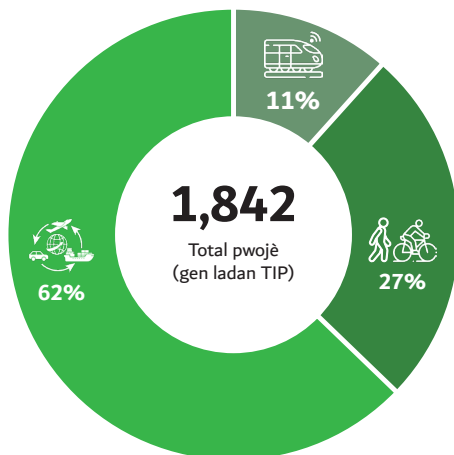
**Relasyon ak Pwogram Amelyorasyon Transpò (TIP)**
